No entries accepted by e-mail or fax per ASFA rules. Make check payable to "LARK". Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries.

If this is your dog's first ASFA trial - you must include the signed ASFA Certification or Waiver (not required for an entry in Singles). You must also include a photocopy of acceptable registry. Your hound must have a registration number, or your entry will NOT be accepted.

This event is being held in conjunction with the Ridgeback Rodeo. ASFA hound certifications and practice will be offered Thursday, Friday and Saturday, 7/25-27/2013 during the Rodeo.

A LARK sponsored LGRA race meet is being held on Sunday, so no coursing will be available on that day. The Premium List for the race meet can be found at the WEB site listed below. If you are entering both the RR ASFA trial and All Breed LGRA race meet, you may make out one check for both events, complete entries for both events and mail all entry forms and entry fees to Gayle Kytta.

ELIGIBILITY: Only purebred Rhodesian Ridgebacks.

All entries shall be individually registered with The American Kennel Club, the United Kennel Club, the Federation Cynologique Internationale, an ASFA Recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial: this requirement is waived for hounds registered with the NGA.

CONDITIONS OF ENTRY: All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Regular Stakes Offered:

OPEN STAKE: Any eligible Rhodesian Ridgeback who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial.

FIELD CHAMPION STAKE: Any Rhodesian Ridgeback ASFA Field Champion.

VETERAN STAKE: Any eligible Rhodesian Ridgeback whose age exceeds seven years and who has met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

SINGLES STAKE: Any eligible Rhodesian Ridgeback including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes, are eligible to enter. Not eligible for Best of Breed or Best In Field Competition. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited Breeds are not eligible for these titles.

There will be a \$5.00 fine for any loose hounds on the field that are not in the course in progress.


